# CALL FOR DEBATER FOR UPCOMING THEATRE PRODUCTION IN TORONTO

# Soulpepper and Nightwood Theatre are casting a BIPOC young woman or gender-expansive debater to perform in the Canadian premiere of the play *What The Constitution Means To Me* by Heidi Schreck in Fall 2024.

#### **ROLE DESCRIPTION**

16-21 years old; Black, Indigenous, or person of colour; young woman or gender-expansive debater with a performative style; experience with debate at the high school and/or university level required; no acting experience required. Performer will use their own name in the show.

#### **ABOUT THE PRODUCTION**

What the Constitution Means To Me premiered on Broadway in 2019 and was a Tony nominee for Best Play and a finalist for the Pulitzer Prize for Drama. In the years since, it has become the most-performed play across the United States.

The American playwright Heidi Schreck earned her college tuition by winning constitutional debate competitions across the United States. In *What the Constitution Means To Me,* which originally starred the playwright as herself, Heidi traces the relationship between four generations of women in her family and the founding document that profoundly shaped their lives. The play allows audiences to explore the dynamic relationship between individuals and the foundational principles of their country, sparking conversations around citizenship, rights, and democracy.

#### ABOUT THE ROLE: THE YOUNG DEBATER

In "part one" of the play, Heidi re-creates the constitutional debate contests of her youth. In "part two," Heidi invites a young debater to join her onstage to help understand how they are thinking about their country and democracy today. This debater introduces themselves with their real-life background, and then they and Heidi stage a debate in real-time with the topic: "Should We Abolish the United States Constitution?" A coin flip decides which side each will take at each performance. Following the debate, Heidi and the Young Debater answer a set of questions that have been submitted by the audience, and finish by reflecting on the future the Young Debater imagines for themselves. The debate and the questions and answers are scripted, with room for ad-libbing.

For the Canadian premiere, Heidi is working with Toronto-based teacher, scholar, and advocate Joshua Sealy-Harrington to re-imagine the play specifically for Canadian audiences.

#### PARTICIPATION REQUIREMENTS

The Young Debater will be required for all rehearsals and performances of the production, including technical rehearsals and dress rehearsal. They will also be required to have all lines memorized by the time rehearsals begin on October 15, 2024.

## COMPENSATION

The Young Debater will receive a weekly fee of \$1,050 for each of the four engagement weeks (October 15-November 10), plus a one-time payment of \$525 for memorizing lines prior to the first rehearsal. The Young Debater will receive two complimentary tickets to Opening Night on Friday, November 1.
